

MUSIC INSTRUMENTAL PROGRAM

Mandurah Catholic College offers a comprehensive range of music tuition. Students enrolled in the Music Instrumental Program receive lessons from a suitably experienced music tutor provided as part of the co-curricular program at the College. Tuition is available in the following instruments:

- Woodwind (Flute, Clarinet, Saxophone)
- Brass (Trumpet, Trombone, French Horn, Euphonium, Tuba)
- String (Violin, Contemporary/Electric Guitar, Guitar, Bass Guitar, Cello)
- Percussion (Drum Kit/Percussion, Piano)
- Voice

Students receive one (non-refundable) 30-minute lesson per week. Lessons will appear on the students SEQTA timetable which can be viewed by parents, students, and teachers.

PAYMENT OF ACCOUNTS

Each parent/guardian who signs the Enrolment Form accepts legal responsibility for payment of school fees and charges incurred for the entire period of the student's enrolment unless court orders state otherwise.

Families will receive their annual school fees invoice at the start of the school year. Unless payment of fees is made in full, a payment plan is required to be in place by 28 February, 2026 (previously 31 March, 2025).

This is done by completing the Payment Option Advice Form and the Payment Agreement attached to the annual school fees invoice. The College offers payment options such as monthly, fortnightly or weekly for payment of fees; and payment methods that include credit card, direct debit and BPay.

Statement of Fees are emailed four (4) times per year. Please ensure the College holds the current email address of the account holder.

All accounts are to be finalised by 30 November, 2026 regardless of the payment option chosen. (Please note the College is considering changing this to 31 October, 2027 next year.)

CUSTODY, COURT/CONSENT ORDERS AND SPLIT FAMILY ARRANGEMENTS

Tuition accounts at Mandurah Catholic College are not 'split' (i.e. invoiced to parents separately). The signatories to the enrolment agreement are jointly and severally liable to pay for all fees and charges incurred in respect of that student, regardless of:

- (a) any pre-arranged or subsequent private agreement to share or apportion payment responsibility
- (b) any Court Order or statutory direction that may apply to any signatory
- (c) any separate or individual invoicing of any amount

This joint and several liability includes all costs that may be incurred by the School in the recovery of fees and charges including legal action, if necessary.

TUITION SWEEP

Families that pay their account in full by 28 February, 2026 will go into the draw to be eligible for a tuition fee credit for their eldest student in 2027, or a refund of their tuition fee if it is their student's last year in 2026. Winners will be contacted directly and announced on the College Facebook page.

AMENITIES FEE

This fee contributes to miscellaneous student related expenses. The balance of this expenditure is subsidised by the College.

ICT LEVY

This contributes to ongoing support of digital learning services through the HelpDesk, ICT devices and infrastructure maintenance and upgrades and all associated licensing and insurance costs.

FAMILY LEVIES

'Parents & Friends' Levy applies to all families. This levy goes towards purchasing resources and equipment necessary for providing students with a quality education. This is charged per family fee account.

Building Levy is a compulsory payment and is **not tax deductible**. This levy applies to all families and contributes towards the College, Maintenance and Capital Development. This is charged per family fee account.

COMPULSORY ACTIVITIES, CAMPS, INCURSIONS, EXCURSIONS AND RETREATS

Correspondence including a Consent2Go notification will be sent detailing the activity. Please note there will be no refund/credits if your child does not attend any planned compulsory activity as these costs are pre-paid up to a year in advance.

INSURANCE

All students will be covered by a comprehensive accident insurance policy which covers students for accidental injuries. This policy should not be considered as a replacement for private health insurance. Parents/guardians are advised to check their Health and General Insurance policies to ensure adequate medical, personal property and liability insurance cover. The College does not accept responsibility for loss of or damage to personal effects and property, or liability incurred by students for property damage.

TOURS

Tours are considered optional and are self-funded by attendees. They may include the Canberra Tour, Europe Tour and Flores Trip. Students will **not** be eligible to participate if school fees account is in arrears or no mutually agreed payment plan is in place.

CONCESSION CARD SCHOOL FEE DISCOUNT SCHEME

This is available to parents/guardians who hold a current means-tested Health Care Card or Pensioner/Veteran's Concession Card which bears the code "PPS". The child/children's name **must** be listed on the card. Applications for concession are available from the Finance Officer or on the College website. The concession card must be provided by 2 April, 2026, to be eligible for full discount. Late applications will be pro-rated. Concessions can only be applied during the validity period of the Health Care Card, ie, discounts will cease with Health Care Card expiry date.

SECONDARY ASSISTANCE SCHEME (YEARS 7 - 12)

This is offered by the Department of Education to parents/guardians holding a current means-tested Health Care Card or Pensioner/Veteran's Concession Card and includes a Clothing Allowance of \$300 (paid directly to the parent/guardian's bank account). Application for this concession has a Government cut-off date of 2 April, 2026.

NOTICE OF WITHDRAWAL

Parents are required to give **one Term's notice in writing** if they choose to withdraw their child from the College. If a student is withdrawn without notice during a term, fees for that term will also be charged, in addition to the term's notice.

Exiting families must settle any outstanding fees within four (4) weeks of exiting the College.

LATE PAYMENT

In ensuring fairness and equity to families who pay fees in accordance with the College's Fee Procedure, the College rigorously follows up overdue accounts. Debt Collection Agencies or Solicitors may also be engaged and any costs incurred by the College in recovering fees will be charged to the account.

FINANCIAL DIFFICULTIES

The College accepts that from time to time, families may find themselves in difficult circumstances. Parents/guardians experiencing genuine financial hardship should contact the College at their earliest opportunity, to discuss alternative options for payment of fees.
